



# **Construction Site Visitor Privacy Notice**

**Thai Shimizu Company Limited** (the "**Company**") would like to inform you ("**You**") who enter into the construction site under the Company's management and supervision (the "**Site**") that the Company would need to collect, store, use, and/or disclose your personal data when you enter the Site. Therefore, for the clarity about the terms and conditions for collecting, storing, using, and processing of your personal data, the Company have announced this Privacy Notice (the "**Notice**"); provided that the Company may revise this Notice from time to time to assure the compliance of this Notice with the Company's necessity to process all the personal data and with the relevant laws and regulations and the Company shall notify You of those revisions through various communication channels.

## Your Personal Data to be processed:

When You enter into the Site, the Company may need to collect the following personal data of You:

- 1. your facial image collected by CCTV system in the Site;
- 2. visitor log record defined in the visitor registration form, including your full name, your identity documents that the Company may collect in exchange of the visitor card; any other information that You may provide to the Company in any other forms; and
- 3. upon the receipt of your consent and for the highest security protection management of the Site, your sensitive personal data such as health information provided in health check report and other type of random checks, fingerprint, or facial recognition.

## **Objectives of Personal Data Processing**

The Company needs to process your personal data as defined in order to protect the Company's legitimate interest in securing the safety of the Site, of You and any person entering the Site and in necessary coordination regarding any situation or incident occurring in the Site.

## **Retention Period of the Personal Data**

The Company would need to process and retain the defined personal data for the following period of time:

- 1. your personal data collected in CCTV system shall be stored for the period of thirty (30) days;
- 2. your original identity evidence shall be returned immediately in exchange of the visitor's card;
- 3. your contact information shall be retained for the period of time necessary for the coordination between the Company and You in case of any incident;
- 4. in order to prepare a report of Site management for the Company's legitimate interest in performing the Company's obligation as required by the relevant Site owner, the Company reserves the right to store your personal data for a minimum period of three (3) years for the standardized audit purposes; and
- 5. in case the Company would need to exercise the Company's legitimate right to protect or defend against You in case of any dispute, the Company would reserve the right to store your personal data for the maximum of ten (10) years which is the general prescription period under the applicable laws.





## **Disclosure of the Personal Data**

Generally, the Company would not disclose your personal data to any person, except in the necessary cases that the Company would need to share and disclose your personal data to the relevant Site owner or the Company may need to disclose your personal data to the government authorities pursuant to the relevant laws or their order; provided that the Company undertakes to only disclose your personal data on the necessary basis.

## Your Right as a Data Subject

The Company acknowledges and respects your and your representative's statutory rights as a data subject under the relevant laws. The data subject rights include the following rights:

- 1. Right to withdraw consent that You have given to the Company,
- 2. Right to access and request for a copy of personal data,
- 3. Right to request the disclosure of the acquisition of personal data obtained without consent,
- 4. Right to request the Company to restrict the use of the personal data, in case the personal data shall be deleted, or such personal data is not necessary to be processed,
- 5. Right to request for data portability,
- 6. Right to object to the process of personal data being undertaken by the Company,
- 7. Right to request the Company to erase or destroy, or de-identify the personal data once the personal data is no longer necessary to be processed or when the data subject revokes his/her consent,
- 8. Right to request to rectify Personal Data, or
- 9. Right to file a complaint in the event of violation of applicable laws.

Should You have any questions or wish to rectify or erase the personal data or to exercise the aforementioned rights or contact the Company regarding the personal data issues or the Company's personal data protection practices, please contact the Contact channel mentioned below.

If You wish to exercise any rights with regard to Items 1 to 9 set forth above, You can submit a request to the Company via Contact channel mentioned below. Once the Company receives your request, the Company will examine the request in accordance with the conditions prescribed by law, complete your request, and notify You of the result of the examination and completion of the request within thirty (30) days from the date of receipt of all requests and supporting documents.

Please note that the Company shall retain its rights under the laws to reject your request in certain circumstances. If the Company decides to reject your request, You will be notified of the reason for such rejection. The Company will try its best, also with considering technical capabilities, to answer your request on how the Company processes the personal data. However, if You have unresolved concerns, You can file a complaint to the Company via the Contact channel mentioned below or proceed further to the authority officials as prescribed by the Personal Data Protection Act B.E. 2562 in case of the Company's infringement or non-compliance with the Personal Data Protection Act B.E. 2562.

## **Review and Changes of Notice**

The Company may review the Notice to ensure that it remains in adherence to laws, or to respond to any significant business changes, and any suggestions and opinions from other organizations. The Company shall announce, and review the amended Notice thoroughly before implementing all the changes. The Company will notify You of such change through the website at https://www.shimz-global.com/th/en/.
